Seth Rosenberg, Jim Kenney Carr Eberbach, Lisa Lee Mollie Fahnestock, Chris Dervishian D.R. Winters Committee (Chair Barbara Amstutz, members Joy Charlton, Kathryn Jones, Sonya Pappas and Heather Saunders) with approval by the Board of Directors.

- \$1,260 to the Ukraine Global Scholars Foundation to cover Ukrainian Swarthmore College student Viktoriia Zakharova's visa and travel costs.
- \$1,000 to the Foundation for Delaware County for their Covid-19 Response Fund.

Last Meeting Summary

Seth Rosenberg returned to Swarthmore Rotary to give us another update on how to protect ourselves and our businesses from email and phone scams. Seth is with the computer security firm, Syncretic. Although most of us probably have heard this message before, Seth said computer and phone refresher security training has to be done periodically because we can all get careless. Even experts make mistakes and allow breaches of personal or business computer systems, as is evident from the recently discovered hacking of U.S. Government agencies.

If we receive a phone call from a company or government agency, we should not give them any personal information. Hang up then look up the number of the company or agency and call back. If we have an online account with the company, we can check there to see if the request for information is legitimate. We should never call back to the same number or any number provided in the original suspicious call.

Seth gave several suggestions regarding emails. Beware of any emailed invoices. Be careful of emails, even from one of your contacts, that request information or provide a link. (Editors Note: I have received emails from Rotary members that were clearly fake.) In both of the above cases, check with the original source before proceeding. Contact the original source by calling on the phone or using an alternate email address.

Seth recommended NoMoreRobo, a service available to Verizon and Comcast customers. This service blocks robocalls on landline phones. As Seth might have said, when it comes to computer and phone security, a little paranoia is a good thing.
